4. Copy of Current NCA Registration certificate -NCA 8 and above
5. Proof of similar works and magnitude
6. Proof of adequate equipment/lease agreement
7. Proof of sound financial standing being bank statement / audited financial statement
8. Litigation history of the company
9. Duly Filled confidential business questionnaire
10. Current single business permit
11. List of key personnel attached with copies of academic testimonials
12. Pre-tender site visit certificate

Interested eligible tenderers may obtain further information from the county website and at sub county notice boards during normal working hours and download tender document free of charge from our website www.kiambu.go.ke

Completed tender documents in sealed envelope bearing no indication of the name of the bidding firm with the contract number and name clearly marked on top should be **deposited in the tender box located at the respective sub county Hall** during the normal working hours.

Interested eligible bidders must meet the requirements in the tender documents so as to reach not later **than 12.00 noon 23rd January 2018** at which time the bid documents will be publicly opened **at the sub county chambers** in the presence of bidders who choose to attend.
